

This Risk Assessment covers the following activities:

Bush Skills: Participants learn the basic priorities of bush survival and complete a series of challenges- constructing a ‘weather-proof’ shelter and building a fire, starting with a ferro rod and steel. Can include a bush cooking component.

Ratio: 1 Instructor and 1 Attending Group Staff per 18 Participants

Age suitability: Year 4+

Location: Horse Paddock and Fire Pit

Benefit of activity: Team development, communication, personal and social learning, adventure

Bush Walk: Participants are led on a guided walk through the beautiful bushland surrounding Tunnel Ridge Ranch and Ewen Maddock Dam.

Ratio: 1 Instructor and 1 Attending Group Staff per 18 Participants

Age suitability: Year 4+

Location: Ewen Maddock Dam trails

Benefit of activity: Exploration, exercise, adventure

	Burns	Possible	Moderate	High	Fire Starting and Bush Cooking: Only takes place in the designated fire pit. Lighting fires is only done in suitable weather conditions. Long hair must be tied back and loose clothing/items must be out of the way. Teams will be spread apart and may be required to take turns to ensure each have adequate space away from other groups/fires. Participants and fires are closely monitored after being lit. Water tap is located nearby with hose to put out the fire at any time or use for first aid if necessary. Fires will be raked at the end of the activity/day and completely put out with water until there are no lit embers.	Unlikely	Minor	Low
