Bush Dance: Participants are led through several partner and line bush dances to music
Ratio: 1 Instructor and 1 Attending Group Staff per 20 Participants
Age suitability: All ages
Location: Dining Hall
Benefit of activity: Fun, personal and social learning

Outdoor/Indoor Games: A variety of games available to suit the group- side games, mini games, spotlight games.
Ratio: 1 Instructor and 1 Attending Group Staff per 20 Participants

Trivia: Teams compete in multiple rounds of general knowledge trivia and games

	Burns	Possible	Moderate	High	Camp Fire: Only takes place in designated fire pit. Lighting fires is only done in suitable weather conditions. Seating is arranged at a safe distance. Long hair must be tied back and loose clothing/items must be out of the way. Marshmallow roasting will be conducted in small group of 5-10 based on the behaviour of the students. Participants and fire are closely monitored after being lit. Water is located nearby to put out the fire or use for first aid if necessary, at any time. Fire will be raked at the end of the activity and completely put out with water until there are no lit embers.	Unlikely	Minor	Low
